Each Grand Prize Winner, Second Prize Winner, Third Prize Winner, Fourth Prize Winner, Fifth Prize Winner, Sixth Prize Winner, Seventh Prize Winner, Eighth Prize Winner, Ninth Prize Winner, Tenth Prize Winner, Eleventh Prize Winner and Twelfth Prize Winner shall be referred to herein as a "Prize Winner". 1. Twelfth Prize Winner: Each Twelfth Prize Winner shall win Fifty Dollars (\$50.00) worth of My Player Perks Points in the form of a check made out to the Winner (the "Twelfth Prize").
