

**“WARMER WEATHER WINNINGS PROMOTION”
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

BY ENTERING INTO THIS PROMOTION, YOU AGREE TO BE BOUND BY THESE OFFICIAL RULES, WHICH CONSTITUTE A CONTRACT, SO READ THEM CAREFULLY. IF YOU DO NOT AGREE WITH THE TERMS AND CONDITIONS OF THIS CONTRACT, DO NOT ENTER THIS PROMOTION.

- 1. PROMOTION OVERVIEW:** The “WARMER WEATHER WINNINGS PROMOTION” (this “Promotion”) is sponsored by Eureka Entertainment, LLC (“Universal Gaming Group”) and the establishments listed in Exhibit A (each, a “Participating Location”) (collectively with Universal Gaming Group, the “Sponsors”). Universal Gaming Group’s principal place of business is located at 240 W. Laura Drive, Addison, IL 60101 (“Universal Gaming Group’s Main Office”). Each Participating Location’s principal place of business is detailed in Exhibit A. This Promotion consists of two (2) separate giveaways: (1) The Grand Prize Giveaway and (2) the Social Media Giveaway (each, as defined below).
- 2. ELIGIBILITY:** The Promotion is open to patrons of each Participating Location who (i) are residents of Illinois, Wisconsin, Iowa or Indiana; (ii) are twenty-one (21) years of age or older at the time of entry; (iii) are enrolled and maintain a valid account with the My Player Perks Program (referred to herein as the “MPP Program”); and (iv) if participating in the Social Media Giveaway, maintain a valid personal account with Instagram (an “Eligible Entrant”) (regardless of whether such patron has or intends to play a Video Gaming Terminal or otherwise make a purchase). Patrons may be required to show a valid identification card (either a driver’s license or other government-issued photo identification) with the patron’s picture, name, address and date of birth at the time of entry to participate. Each person who enrolls in the Promotion is referred to herein as a “Participant”. The following persons are ineligible to participate in the Promotion and/or to win a prize, even if they otherwise meet the definition of an Eligible Entrant: *employees, officers, directors, agents, owners, successors and assignees of the Sponsors, their respective parent, subsidiaries and affiliated companies, any advertising, promotional agencies, or other entity otherwise involved in the creation, administration or fulfillment of this Promotion* (all of the above italicized entities collectively referred to herein as “Promotion Parties”), and the immediate family members (defined as spouse, parent, child, sibling or grandparent; whether biological, adoptive, step or in-law) and those living in the same household (defined as those persons whether related or not who live in the same residence as the Eligible Entrant at any time during the Promotion Period, as defined below) of such Promotion Parties. Each Participant is limited to creating one (1) account for the MPP Program. Each Participant who participates in the Social Media Giveaway is limited to creating one (1) valid personal account with Instagram.
- 3. PROMOTION DATES:** The Grand Prize Giveaway will begin on Tuesday, April 15, 2025, at approximately 7:00 a.m. CST and conclude on Monday, May 19, 2024, at approximately

11:59 p.m. CST (the “Grand Prize Giveaway Period”). The Social Media Giveaway will begin on Tuesday, April 15, 2025, at approximately 7:00 a.m. CST and conclude on Monday, May 19, 2024, at approximately 11:59 a.m. CST (the “Social Media Giveaway Period”). Sponsors reserve the right to shorten or extend the Promotion Period. The Grand Prize Giveaway Period and the Social Media Giveaway Period are collectively referred to as the “Promotion Period”.

4. PROMOTION PROCEDURES:

- a. Grand Prize Giveaway: Participants may enter the grand prize giveaway (the “Grand Prize Giveaway”) during each Participating Location’s regular business hours throughout the Grand Prize Giveaway Period. Participants can enter by checking-in to the MPP Program via the in-store MPP Program kiosk or the My Player Perks app (each, a “Grand Prize Giveaway Entry” and collectively the “Grand Prize Giveaway Entries”). Each check-in constitutes one (1) Grand Prize Giveaway Entry. For the avoidance of doubt, each check-in will constitute one (1) Grand Prize Giveaway Entry regardless of whether the Participant used the in-store kiosk or My Player Perks app to check-in. In order for a check-in to constitute a Grand Prize Giveaway Entry, Participant’s MPP Program account must include the (a) first and last name, (b) primary telephone number, (c) email address, and (d) birth date in acknowledgment of being at or above the age of twenty-one (21). Grand Prize Giveaway Entries must be filled out completely to be eligible. All Grand Prize Giveaway Entries become property of the Sponsors. Each Participant is limited to one (1) Grand Prize Giveaway Entry per sixty (60) minutes throughout the Promotion Period. Grand Prize Giveaway Entries that are incomplete, illegible, misspelled, damaged, destroyed, late, misdirected, deceptive or otherwise not in compliance with the Official Rules may be disqualified from the Grand Prize Giveaway, at the Sponsors’ sole and absolute discretion.

- b. Social Media Giveaway: During the Social Media Giveaway, patrons with a valid personal account with Instagram may enter the social media giveaway (the “Social Media Giveaway”) by (a) finding and taking a picture with a Participating Location’s on-site Warmer Weather Winnings Magnet (the “Social Media Photo”) and (b) visiting Instagram and (i) finding and following @myplayerperks; (ii) posting such Social Media Photo on the Participant’s personal Instagram page (the “Post”); (iii) and mentioning the Participating Location in the caption; and (iv) tagging @myplayerperks in the Post (each, a “Social Media Entry” and collectively the “Social Media Entries”). Each Participant is limited to one (1) Social Media Entry per calendar day. All previous Social Media Entries will be discarded directly after each Social Media Prize Drawing (as defined below). For the avoidance of doubt, each Social Media Photo must not be previously used in a Post in order to be considered as a Social Media Entry. For example, if a Participant was to use the same Social Media Photo on different calendar days in his or her Post, each subsequent Post would not be considered as a Social Media Entry. To obtain an account on Instagram, visit www.Instagram.com to register.

Social Media Entries that are incomplete, illegible, misspelled, damaged, destroyed, late, misdirected, deceptive or otherwise not in compliance with these Official Rules may be disqualified from the Social Media Giveaway, at the Sponsor’s sole and absolute discretion. Attempts made by the same individual to submit multiple entries by using

multiple Instagram accounts, emails, addresses or other means may be disqualified. All Social Media Entries submitted via Instagram are subject to Instagram’s data policy and terms of use, which can be found at <https://help.instagram.com/155833707900388> and <https://help.instagram.com/581066165581870/>, respectively.

Upon completion of the promotion procedures outlined in Section 4, Participant will be automatically entered into the Grand Prize Giveaway and/or Social Media Giveaway, as applicable. By entering this Promotion, each Participant agrees that (A) they have read and accepted these Official Rules; (B) they have read and accepted the Universal Gaming Group Privacy Policy, which is available at <https://ugaminggroup.com/privacy-policy/>; (C) they have read and accepted the My Player Perks Privacy Policy, which is available at <https://myplayerperks.com/privacypolicy/PreviewPrivacyPolicyProgram?rpid=ffc2857a-0c99-4f5a-8404-621301f1244c>; and (D) they have read and accepted the My Player Perks Terms of Use, which is available at <https://myplayerperks.com/TermsOfService/PreviewTOSRewardProgram?rpid=ffc2857a-0c99-4f5a-8404-621301f1244c>, which is incorporated by reference and made a part of these Official Rules.

5. SELECTION OF WINNERS:

- a. **Grand Prize Giveaway:** On Tuesday, May 20, 2025, at approximately 12:00 p.m. CST (the “Finalist Prize Drawing”), a representative of Universal Gaming Group will electronically randomly select one (1) Grand Prize Entry from each Participating Location (each, a “Finalist Prize Winner” and collectively the “Finalist Prize Winners”). The number of Finalist Prize Winners is entirely dependent on the number of Participating Locations. On Thursday, June 5, 2025, at approximately 5:00 p.m. CST via the My Player Perks Facebook page on a Facebook Live event (the “Grand Prize Drawing”), a representative from Universal Gaming Group will randomly select from all Finalist Prize Winners ten (10) winners (each, a “Second Prize Winner” and collectively the “Second Prize Winners”) to win the Second Prize (as defined below) and five (5) winners (each, a “Grand Prize Winner” and collectively the “Grand Prize Winners”) to win a Grand Prize (as defined below).
- b. **Social Media Giveaway:** Each Monday (as detailed below) at approximately 12:00 p.m. CST (each, a “Social Media Prize Drawing”), a representative of Universal Gaming Group will electronically randomly select one (1) winner (each, a “Social Media Prize Winner” and collectively the “Social Media Prize Winners”) from all Social Media Entries obtained within such Social Media Prize Drawing’s Social Media Giveaway Entry Period (as described in the table below) for a total of five (5) Social Media Prize Winners by the conclusion of the Promotion Period.

Each Grand Prize Winner, Second Prize Winner, Finalist Prize Winner and Social Media Prize Winner shall be referred to herein as a “Prize Winner”. By entering this Promotion, each Participant agrees that they have read and accepted these Official Rules. **Participant is eligible to be a Finalist Prize Winner one (1) time. Participant is eligible to be a Second Prize Winner one (1) time. Participant is eligible to be a Grand Prize Winner one (1) time. Participant is eligible to be a Social Media Prize Winner one (1) time. Participant need not be present to win.**

6. NO PURCHASE IS NECESSARY TO ENTER OR WIN THIS PROMOTION. FURTHER, A PURCHASE (INCLUDING, WITHOUT LIMITATION, PLAY OF VIDEO GAMING TERMINALS OR THE PURCHASE OF ANY PRODUCT, GOOD OR SERVICE SOLD BY ANY SPONSOR) WILL NOT IMPROVE A PARTICIPANT’S CHANCES OF WINNING A PRIZE IN THIS PROMOTION.

There is one (1) Backyard Bundle available. Total ARV of the Backyard Bundle is One Thousand Seven Dollars and Eighty-Nine Cents (\$1,007.89).

- b. Second Prize Winners: Each Second Prize Winner shall win one (1) Five Hundred Dollar (\$500.00) Cash Prize in the form of a check made out to the Winner (each, a “Second Prize” and collectively the “Second Prizes”). Cash Value of each Second Prize is Five Hundred Dollars (\$500.00). There will be ten (10) Second Prize Winners and a total Cash Value of Five Thousand Dollars (\$5,000.00) in Second Prizes awarded.
- c. Finalist Prize Winners: Each Finalist Prize Winner shall win one (1) One Hundred Dollar (\$100.00) Amazon Gift Card and one (1) entry into the Grand Prize Drawing (each, a “Finalist Prize” and collectively the “Finalist Prizes”). ARV of each Finalist Prize is One

Hundred Dollars (\$100.00). The amount of Finalist Prize Winners and total ARV of Finalist Prizes awarded are entirely dependent on the number of Participating Locations.

- d. Social Media Prize Winners: Each Social Media Prize Winner shall win one (1) Mystery Item (each, a “Social Media Prize” and collectively the “Social Media Prizes”). ARV of each Social Media Prize is One Hundred Dollars (\$100.00). There will be five (5) Social Media Prize Winners and a total ARV of Five Hundred Dollars (\$500.00) in Social Media Prizes awarded.

The odds of an Entry being randomly selected as a Prize Winner depend entirely on the number of Entries received during the Promotion Period. Each Prize Winner will be randomly selected. Each Grand Prize, Second Prize, Finalist Prize and Social Media Prize cannot be transferred or exchanged for cash or other goods and services and must be accepted as awarded. It is the Participant’s responsibility to read and understand all information. If the Prize Winner fails to collect the prize within the applicable collection period, such winner’s rights to the prize will be automatically forfeited, and Sponsors shall have the discretion to select a new winner.

8. PRIZE WINNERS’ NOTIFICATION PROCEDURES:

- a. Grand Prize Giveaway:
 - i. Finalist Prize Winners: Each Finalist Prize Winner will be notified by a representative of Universal Gaming Group by telephone at the telephone number used in connection with the Grand Prize Giveaway Entry no later than seventy-two (72) hours from the time the Finalist Prize Drawing was conducted. Each Finalist Prize Winner will have three (3) days from the time of the initial phone call to respond. In the event that the Finalist Prize Winner has not responded within the applicable response period or has entered an invalid telephone number, such Participant shall be disqualified from the Promotion, and Sponsors shall have the discretion to select a new winner.

- ii. Second Prize Winners: Each Second Prize Winner will be notified by a representative of Universal Gaming Group by telephone at the telephone number used in connection with the Grand Prize Giveaway Entry no later than seventy-two (72) hours from the time the Grand Prize Drawing was conducted. Each Second Prize Winner will have five (5) days from the time of the initial phone call to respond. In the event that the Second Prize Winner has not responded within the applicable response period or has entered an invalid telephone number, such Participant shall be disqualified from the Promotion, and Sponsors shall have the discretion to select a new winner.
 - iii. Grand Prize Winners: Each Grand Prize Winner will be notified by a representative of Universal Gaming Group by telephone at the telephone number used in connection with the Grand Prize Giveaway Entry no later than seventy-two (72) hours from the time the Grand Prize Drawing was conducted in the order in which the Grand Prize Winners were drawn. Each Grand Prize Winner will have the ability to choose his or her Grand Prize from the available Grand Prizes at the time of his or her response. Each Grand Prize Winner will have ten (10) minutes to respond to the phone call before the next Winner is called and given the opportunity to select his or her Grand Prize. Each Grand Prize Winner will have five (5) days from the time of the initial phone call to respond. In the event that the Grand Prize Winner has not responded within the applicable response period or has entered an invalid telephone number, such Participant shall be disqualified from the Promotion, and Sponsors shall have the discretion to select a new winner.
- b. Social Media Giveaway: Each Social Media Prize Winner will be notified by a representative of Universal Gaming Group by direct message to the Instagram account used in connection with the Social Media Giveaway Entry no later than seventy-two (72) hours from the time the applicable Social Media Prize Drawing was conducted. Each Finalist Prize Winner will have three (3) days from the time of the initial direct message to respond. In the event that the Finalist Prize Winner has not responded within the applicable response period or has entered an invalid telephone number, such Participant shall be disqualified from the Promotion, and Sponsors shall have the discretion to select a new winner.
 - c. Each Prize Winner must complete either an “Affidavit of Eligibility” and/or a “Receipt, Release and Discharge Form” before accepting his or her prize.
- 9. CONDITIONS:** All taxes, costs, and other expenses not otherwise set forth herein are the sole responsibility of each winner. Each Prize Winner may be required to provide tax information and may be sent an IRS Form 1099. Each winner is solely responsible for reporting and paying all applicable federal, state and local taxes related to the prize. Prizes cannot be transferred or exchanged for cash or other goods and services.

10. MISCELLANEOUS:

- a. By entering the Promotion, each Participant unconditionally agrees to be bound by these Official Rules and the decisions of the Sponsors, which shall be final. The Sponsors reserve

the right to disqualify any Participant or Prize Winner who, in Sponsors' sole discretion, tampers with the entry process, violates these rules, or acts in an unsportsmanlike or disruptive manner. In the event of a discrepancy between these Official Rules and any creative/collateral materials relating to this Promotion, these Official Rules will prevail.

- b. All federal, state, and local laws apply, and all applicable federal and state taxes are the sole responsibility of the Prize Winner.
- c. The Sponsors and, as applicable, Promotion Parties are not responsible for and shall not be liable for: (i) late, lost, delayed, damaged, misdirected, incomplete, illegible, or unintelligible entries; (ii) any condition caused by events beyond the control of the Sponsors that may cause this Promotion to be disrupted or discontinued; (iii) any injuries, losses, or damages of any kind caused by a prize or resulting from acceptance, possession, or use of a prize, or from participation in this Promotion; (iv) any printing or typographical errors in any materials associated with this Promotion, or (v) late, lost, delayed, or damaged delivery of the prize.
